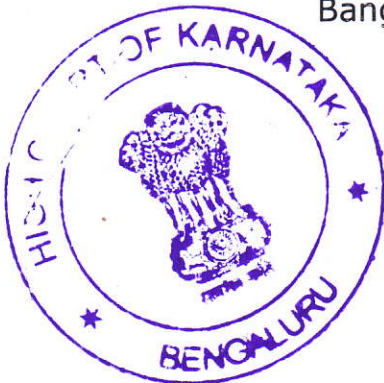

This Writ Petition is filed under Articles 226 and 227 of the Constitution of India praying to declare Section 36A of the Karnataka Police Act, 1963, as ultra vires Articles 14, 15, 19 and 21 of the Constitution of India, and etc.

This petition coming on for Orders this day, **the Chief Justice** made the following:

ORDER

This writ petition is filed seeking for a declaration that Section 36A of the Karnataka Police Act, 1963, is ultra vires of the Constitution of India.

2. When the matter is taken up for hearing, Shrimati S.Susheela, learned additional government advocate, informs that there has been an amendment to Section 36A as aforesaid. It is said that the transgenders were singled out



in the provisions of law. Now the law has been amended.
The expression "eunuchs" has been deleted

3. In view of the amendment, nothing is left for decision
in the matter. The writ petition is, therefore, disposed of.

4. In view of disposal of the writ petition, the pending
interlocutory applications do not survive for consideration
and are, also, disposed of.

5. We make no order as to costs.
