# About the Workshop :

It appears that the Democratic process in India instead of minimizing Caste and Religious conflicts has been encouraging and strengthening parochial sentiments with adhoc concessions to traditional beliefs and prejudices. The state and the law directly or indirectly legitimize and promote such conflicts by ensuring strong exceptions to the basic values underlying the Constitution such as equality before the law, equality of opportunity, non-interference with religious practices, protection of property and liberty of the citizen.

The state can avoid such conflicts only when it can command the loyalty of every citizen by removing, as far as possible, diverse cultural and religious traditions from the public sphere through building consensus on universally acceptable and constitutionaly articulated goals and principles. The events surrounding "Temple Entry" once again brought to the surface conflicts due to the absences of consensus on basic values underlying the Constitution. The primary objective of the workshop is to sensitize the participants the need for identification of basic values and principles, and the means and methods by which they can be institutionalized in the working of this largest democracy.

Hence the proposed workshop on "Constitutional Foundations of State Regulation of Religious Beliefs and Practices" intended to deliberate on issues relating to building consensus on goals and principles that could mitigate conflicts and promote social cohesion and national integration.

The workshop is basically inter-disciplinary and during the workshop reputed resources persons in the disciplines of law and political sciences will make their presentations on the topic such as scope and content of constitutionally protected individual freedom of religion, the extent of state control over individual and groups freedom of religion, conflicting claims of secular state and religious society, and the necessity of building consensus on certain basic values.
