ORDER ON MISC.W.2435/2010

Having gone through the application filed for issuance of directions and on hearing Mr.Anand Grover, learned senior counsel representing the petitioners, we direct the 3rd and 4th respondents to look into the matter and submit whether any measures are taken to comply with the procedure and the Rules made thereunder to prohibit or ban the sale of tobacco and tobacco products within 100 yards from the educational institutions either the School or the College concerned.

We specifically direct the 3rd and 4th respondents to see that Display Boards banning such sale, shall be put up compulsorily by the institutions concerned and



proper circulars have to be issued to the concerned Departments of 3^{rd} and 4^{th} respondents.

Meanwhile, we also direct the 5th respondent to make an inspection with the assistance of the petitioner to find out whether there is such sale of tobacco and tobacco products within 100 yards from the educational institutions coming in the jurisdiction of 5th respondent. They are also directed to file a many the effect how that report to shops/hawkers/sellers are situated and whether they have taken any measures to make inspections at random to find out what exactly is happening so far as the sale of tobacco and tobacco products are concerned.

Misc.W.2435/2010 for direction, is *allowed* accordingly.


