Keeping open all contentions, the pendency of this proceeding would not debar the State from proceeding



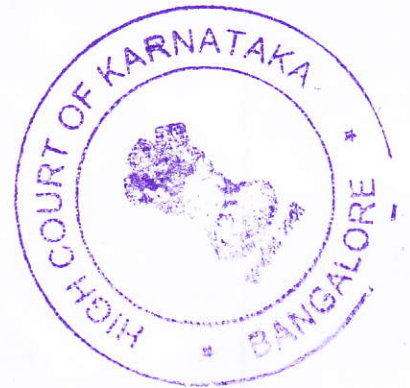
