In the interregnum, the demand of the Bangalore Development Authority for payments from the petitioners shall remain stayed until further orders.

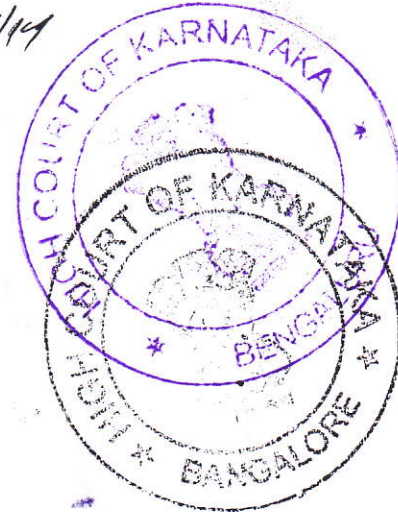
