#### **FORMAT**

- This will be followed by a formal dinner where the speakers can engage in fruitful conversations with the college student body and the general public.

For the XI Edition of The NLS Student Bar Debate (formerly known as the NLS Union Debates), we have invited 2 guest speakers in addition to 1 student speaker from NLSIU on each side. Therefore, there will be 6 speeches, each lasting ten minutes.
