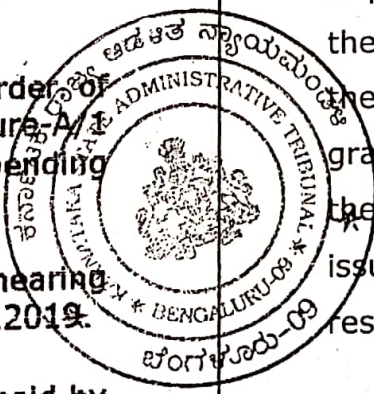
INTERIM PRAYER
