Sri R. Subramanya, the learned Additional Advocate General is directed to take notice for respondent Nos. 1 and 3.

Issue emergent notice to respondent No.2. Petitioner is also permitted to take out hand summons to respondent No.2.

There is single echogenic intracardiac focus (EIF) in the Thereafter the petitioner went left ventricle". 'MEDGENOME' - Centre for Genetic Health Care, for second opinion, where the three doctors consisting Ms. Vishalakshi Kamath and Dr. Shailesh Kumavat, who are Cytogenicists and Dr. Hema Purandarey, Founder Director - Centre for Genetic Health Care, have opined on 24.10.2019 that the 'Analysis revealed presence of three orange signals representing three copies of chromosome 21 suggesting aneuploidy for chromosome 21. There is no aneuploidy of chromosome 13, 18 and The Findings are thus consistent sex chromosomes. with Trisomy - 21 (Down Syndrome)'. Therefore, the petitioner is before this Court for the relief as sought for.

In view of the above, respondent No.3 – Bangalore Medical College and Research Institute is directed to constitute a Medical Board consisting of Specialists, who are handling the cases of termination of pregnancy so as to examine the petitioner and submit a report in a sealed cover before this Court.

The petitioner is directed to appear before the 3rd respondent on 28.10.2019 (tomorrow) at 10.30 a.m. and the Medical Board taking into consideration the peculiar facts and circumstances of the present case, as the length of the pregnancy of present petitioner is exceeding 30 weeks, shall take immediate action and submit a report in a sealed cover to this Court on or before 30.10.2019.
