14	ABHAY SHREENIWAS OKA (CJ) AND SURAJ GOVINDARAJ	20/07/2021	We have perused the amendments made by the State Government to the Karnataka Civil Services (General Recruitment), Rules 1977 by the Karnataka Civil Services (General Recruitment) (Amendment) Rules, 2021 by incorporating Sub-Rule 1(D) in Rule 9. It provides for one percent reservation to the transgenders. The learned counsel appearing for the fourth respondent – Union of India states that the fifth respondent had also submitted a report recommending reservations for transgenders and accordingly, directions had been issued to the State Governments. The learned counsel appearing for the fourth respondent states that within two weeks, along with the statement of objections, a report of the National Commission for Backward Classes (fifth respondent) shall be placed on record. The counsel for the petitioner is not present. The learned counsel for the intervener states that an application will be made for issuing notices to other public authorities in the State so that directions can be issued even to the said authorities. List the petition on 18th August 2021.
15	ABHAY SHREENIWAS OKA (CJ) AND N S SANJAY GOWDA	18/08/2021	ORDER ON I.A.No.1/2021 Heard the learned senior counsel appearing for the applicant and the learned Additional Government Advocate appearing for the State. The prayer made in the application in terms of prayer (A) reads thus; "A. Direct that reservation of one percent horizontal reservation to transgender candidates, as provided under the Karnataka Civil Services (General Recruitment) (Amendment) Rules, 2021 be extended to all State Boards and State owned Corporations and other public authorities in Karnataka" The learned Additional Government Advocate appearing for the State Government states that it will be appropriate, if the State Boards and the State owned Corporations are made parties to this petition by the petitioners. Ultimately, it is for the petitioners to decide whether they want to implead the State owned Corporations and Boards set up by the State as the parties. The State Government has taken an innovative step to provide one percent of reservation to the transgenders in the employment as provided in the Karnataka Civil Services (General Recruitment)(Amendment) Rules, 2021. Considering the policy of the State as reflected from the amended Rules, the State Government shall consider of issuing directions/Advisories to the State owned Corporations and the statutory authorities established under the State enactments to provide for similar reservations. The State Government shall place on record, the appropriate action taken in terms of this order within a period of six weeks from today. With the above directions, the application is disposed of. List the petition on 22nd September, 2021
