He is on the Board of Directors, International Legal Assistance Consortium (ILAC) which works to strengthen the rule of law, empower legal professionals and ensure equal access to justice. **N. Krishnaveni** is a Senior Advocate practicing at the Madurai Bench of the Madras High Court with over three decades of experience appearing in original and appellate civil matters. She served as Secretary, Madurai Bench of Madras High Court Bar Association (MMBA) and President, Women Advocates' Association before becoming the first woman to be elected President of the MMBA in 2016. She is also an Honorary Vice-President of the All India Federation of Women Lawyers.



**Anita Shekhar Castellino** is a Counsel at the Bombay High Court with almost thirty years' experience. She is the Convenor, Interactive Lawyers Association of Women (ILAW), which was instrumental in demanding posts for women lawyers at the Bombay Bar Association. This led to the BBA passing a resolution in 2024 introducing 5 posts for women. She is currently serving as an Executive Committee Member, Bombay Bar Association.



**Vivek Subba Reddy** is a Senior Advocate at the High Court of Karnataka and twice-elected President of the Advocates' Association of Bangalore. A graduate of University Law College, Bangalore, he has thirty years' experience at the Bar, appearing in civil and commercial matters. He is also a National Media Spokesperson and member of the Bharatiya Janata Party.



**Ms. Vibha Datta Makhija** is a Senior Advocate at the Supreme Court of India. She graduated from Campus Law Centre, University of Delhi, and pursued an LL.M. from Georgetown University Law Centre before joining the bar in 1992. Her areas of practice include constitutional and criminal law, education law, arbitration, and insolvency laws. # JUSTICE IN NUMBERS: DATA-DRIVEN LAW REFORM



**Prof (Dr.) Rangin P. Tripathy,** is a Professor of Law at the National Law University of Odisha (NLUO). A law graduate of Utkal University, he went on to earn an LL.M from National Law School of India University Bangalore and a PhD in Law from NLUO. In 2020, he completed his Post-Doctoral Fellowship at Harvard Law Schol as a Fulbright Scholar. He is the Director, Centre for Public Policy, Law and Good Governance (CPPLGG), which launched the KHOJ (Know Your High Court Judges) dataset available on JusticeHub, an open-source data platform related to the Indian justice system.



**Prof (Dr.) Aparna Chandra,** is a Professor at the National Law School of India University, Bangalore (NLSIU) who specialises in constitutional law, human rights, gender and the law and judicial process reform. She is a co-convenor of the Indian Feminist Judgments Project and has authored books and articles focused on legal reforms, including Court on Trial: A Data-Driven Account of the Supreme Court of India.



**Apoorv Anand** is the Head of Data Operations at Data for India, a public platform that uses data from the Indian government and international agencies to produce insights and charts on socio-economic issues. # JUDICIAL DIVERSITY : REFLECTIONS FROM THE BENCH



Justice Ashok B. Hinchigeri is the Chairman, Law Commission of Karnataka and a former judge of the High Court of Karnataka. During his tenure as a judge, he was the Chairman of the Juvenile Justice Committee and served as Governor on the Board of the Karnataka Judicial Academy. In October 2024, Justice Hinchigeri was appointed to his present role as Chairman of the Law Commission of Karnataka.





Justice S. Sujatha is the Judicial Member, Central Administrative Tribunal, Bengaluru and former judge of the High Court of Karnataka. Prior to her elevation to the High Court, she practiced as an advocate, during which time she served as a High Court Government Pleader and Additional Government Advocate. She retired in May 2022. During her tenure, Justice Sujatha passed significant orders on the right to education, right of selfidentification of transgender persons and the right to marry. In August 2022, she was appointed to her current position as Judicial Member, CAT, Bengaluru.



Justice Mukta Gupta served as a judge of the Delhi High Court from 2009 to 2023. She earned her law degree from Campus Law Centre, Delhi University, and joined the bar in 1984. Appointed as an Additional Public Prosecutor in 1993, she later became the Standing Counsel (Criminal) for the Government of NCT Delhi, prosecuting high-profile cases. She also represented the CBI as Special Counsel and was a member of the Delhi Legal Services Authority. As a judge, she delivered decisions on criminal, civil, commercial, and intellectual property law, as well as arbitration. She chaired the Delhi High Court's Juvenile Justice Committee. After retirement, she resumed practice as an advocate in the Supreme Court.



Jayna Kothari is a Senior Advocate and practices in the Supreme Court of India. She is also the founder and Executive Director of the Centre for Law and Policy Research, Bangalore. She graduated from University Law College with a B.A. LL.B degree and read the BCL at Oxford University. She was awarded the Wrangler D.C. Pavate Fellowship in Cambridge University. Her research and practice interests include constitutional law, gender and sexuality law, disability rights and discrimination law.
