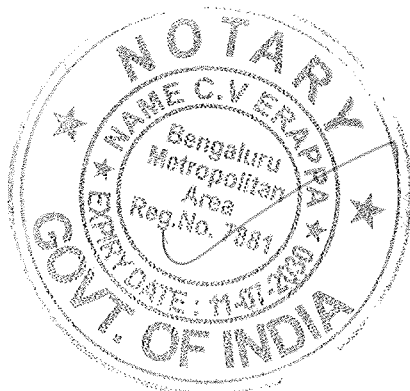

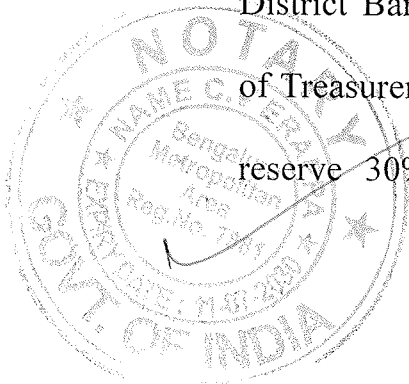
**REPLY AFFIDAVIT ON BEHALF OF THE PETITIONER TO THE
COMPLIANCE REPORT AFFIDAVIT DATED 3.9.2025**

I, Smt. Sandhya B. Madinur, W/o Mr. Basavareddy Y Madinur, aged about 66 years, President and authorised signatory of the Karnataka Federation of Women Lawyers, having its office at Ladies Room, High Court Building, Ambedkar Vidhi, Bengaluru – 560001, R/o No. 11 Bandvya Hudco do hereby solemnly affirm as under:

1. That I am serving as the President of the Petitioner Federation and I am familiar with the facts of the captioned matter and as such am competent to swear this Affidavit.
2. That the Petitioner Federation has filed the captioned petition in which this Hon'ble Court vide order dated 24.1.2025 was pleased to invoke Article 142 of the Constitution of India and pass directions to the effect inter alia that, (i) the post of Treasurer of the Advocates' Association, Bengaluru shall be exclusively earmarked for women candidates, (ii) the High -Powered Committee and Chief Returning Officer to consider the desirability of ensuring that at least 30% elected members of Governing Council of Advocates Association Bengaluru are women candidates. These directions were made absolute by way of subsequent order dated 28.1.2025.
3. That thereafter, on 24.3.2025, this Hon'ble Court passed an order that the directions contained in order dated 28.1.2025 in respect of Advocates' Association, Bengaluru shall apply mutatis mutandis in the matter of the elections of District Bar Associations in the entire State of Karnataka. All District Bar Associations were accordingly directed to earmark the post of Treasurer exclusively for women candidates and are further directed to reserve 30% of the posts of Councilors/Members of the Executive


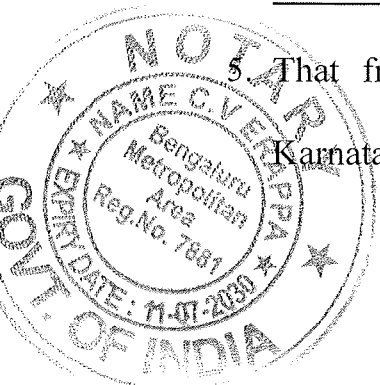


Committee for women candidates. It was further clarified that each Bar Association, after holding the election shall submit a compliance report to their respective District and Sessions Judge who shall forward the same to the Registrar General of the High Court. The Registrar General would thereafter file a comprehensive compliance report. That following this, the Registrar General, High Court of Karnataka has filed a Compliance Report Affidavit dated 3.9.2025. The Compliance Report carried a “statement showing compliance reports of the Bar Associations of the State of Karnataka.” This statement carries a status indicating that some Bar Associations have complied with the directions and that others are yet to comply and they undertake to do so.

4. That in order to assist this Hon’ble Court, the Petitioner Federation has verified to the extent possible on the compliance of the orders of this Hon’ble Court, by the Bar Associations in Karnataka and has attempted to provide the status to the Hon’ble Court and where possible support this with appropriate documentation/notification/order implementing the directions of this Hon’ble Court.

SUMMARY OF COMPLIANCE

5. That from the data collected it appears that implementation across Karnataka, even after almost one year of the said orders being passed, the

compliance has not been done adequately. An executive summary of the compliance as determined by the Petitioner is as follows:

A. Full Compliance with Directions of this Hon'ble Court to appoint a woman to the Treasurer post and to appoint women to 30% of the Executive Council Members – 4 Bar Associations
